2022 OCBA SECTION LEADERSHIP ELECTIONS LEADERSHIP OPPORTUNITIES AVAILABLE

Section leadership is of vital importance, given the significance of Sections in continuing education and business networking in particular areas of the law, which is a core focus of our bar. This fall, all OCBA sections will conduct online elections for the open leadership position of **Secretary/Treasurer**. (Per the OCBA bylaws, the 2021 Section Chair-Elect and Secretary/Treasurer will automatically move up to 2022 Chair and Chair-Elect, respectively.) The elections will be conducted on a staggered schedule from October thru December, and the section leaders will take office in January, 2022 for a one-year term. All active attorneys who are members of a Section as of October 1, 2021, will be able to nominate and vote for their respective leaders, and are also eligible to serve in a leadership position within that Section. [**Self-nominations are highly encouraged.**]
