Unlawful Presence Waivers of Inadmissibility: A Review and Updates

DHS recently published a final rule expanding eligibility for provisional unlawful presence waivers to all individuals who are statutorily eligible for an unlawful presence waiver and who can establish extreme hardship to a U.S. citizen or lawful permanent resident (LPR) spouse or parent. In addition, the rule implements several changes to the existing provisional waiver rules that will affect how you present your cases to USCIS and prepare your client for the consular interview.
